ROYAL WEEKEND AT THE QUÉBEC WINTER CARNIVAL CONTEST

Contest Rules December 31, 2015 to January 13, 2016

- 1. This contest is open only to Quebec and Ontario residents who have reached the age of majority, except employees, representatives and agents of the Sponsors or their affiliated companies (including employees of Uniprix Inc. and of all stores of the Uniprix network), and, if applicable, their advertising or promotional agencies, contest judges, contest prize suppliers, any other companies engaged in the development, production or distribution of materials for this contest, and members of the immediate families of, or persons domiciled with, any of the above.

confirmed under these Contest Rules shall be disqualified.
