# "YOUR PARTNER IN HEALTH!" CONTEST

#### Entry rules from April 12 to May 9, 2018

- **1.** The sponsor of this contest is Uniprix (the "Sponsor"), a division of Corporation Groupe Pharmessor (the "**Sponsor**" or "**Uniprix**").
- 2. This contest is open only to residents of Quebec, who have reached the age of majority, except employees, representatives and agents of the Sponsor or their respective affiliated companies (including employees of the Sponsor and all the stores in the Uniprix network) and, if applicable, its respective advertising and promotional agencies, contest judges (if applicable), contest prize suppliers, any other companies engaged in the development, production or distribution of materials for this contest, and immediate family members of, or persons domiciled with, any of the above.

With every purchase of \$25 or more of eligible products, you will have a chance to win by completing the in-store entry ballot, which must include your eligible receipt number and the store and transaction numbers. Entry ballots without the eligible receipt number, store number and transaction number will be automatically rejected. Entry ballots must be filled out and deposited in the drawing boxes found in participating Uniprix stores;
  - b. **No purchase necessary to enter.** You can enter the contest by sending a handwritten entry form with your name, address, postal code, telephone numbers (day and evening) and an original letter of at least 50 words (no photocopies) explaining why you should win this contest. Entries should be sent to the address below. Each letter entitles you to one chance to win.

## Bookings must be made by December 15, 2018. NO EXTENSION SHALL BE GRANTED.

- a) Round-trip transportation between the winner's residence and the airport, as well as the guest's transportation, will be at the winner's expense;
- b) The trip must be booked and completed by April 30, 2019;
- c) Departure dates for the trip will be determined by the agency and subject to hotel and airline availability. Blackout dates include:
  - Construction holiday (July 21 to August 5, 2018)

  - School break (February 18 to March 24, 2019);
  - Easter (April 12 to 22, 2019);

  - c. Correctly answer a timed mathematical skill-testing question, without assistance, that will be administered by telephone by the Sponsor or its representatives at a mutually set time;
