

## Enter our “Happy Easter 2015” Contest!

### Contest Rules

**March 19, 2015 to April 8, 2015**

1. To enter our “**Happy Easter**” contest, simply colour in the drawing available at participating Uniprix stores or on our Website at [www.uniprix.com](http://www.uniprix.com). Then, fill in the contact information and drop off the colouring page in the contest box **before noon on April 8, 2015**.

2. Manually or mechanically reproduced colouring pages will not be accepted, nor will those completed using a rubber stamp or dry labels. One colouring page per person, per DAY. No purchase required.

3. The contest opens on March 19, 2015 and closes on April 8, 2015, at noon. **Random draws will take place on May 6, 2015, at 1:00 p.m.**, from all eligible entries, at the Uniprix head office, located at 5000 Métropolitain Blvd. East in St-Léonard.

#### 4. PRIZES
